# OUTLINE OF "PIER" PROJECT

ICETT is pleased to inform a new environmental project on Invitation to Japan for Environmental Research (PIER), that invites research fellows who work in governments or higher academic institutions in Developing countries, in order to let the researchers to extend their studies more in cooperation with advice of Japanese institutes.

This is a prestigious project being in accordance with the fundamental principle of "2005 World Exposition, Aichi, Japan" \*1 that was closed in September 2005. For the sake of contributing the environmental conservation both at global and local level, we are willing to provide the overseas researchers for opportunities that they can freely undertake his/her research.

(\*1 What is the philosophy of the 2005 World Exposition, Aichi, Japan?: To explore and propose about the Nature's Wisdom by global harmony and people's exchange in the way of 21<sup>st</sup> centuries.)

Therefore, we expect that the project opportunity be fully utilized for the study on environmental technology towards sustainable development by the researchers, and then, to give back or transferred some of the result to their society.

This project funds are donated from many people concerned to the 2005 World Exposition, Aichi, Japan<sup>\*2</sup> established in the end of March 2007. The project will be conducted every year until 2011 for five years.

Selected academic committee members in Japan and ICETT will review your contents applied, then if it is wonderful and meets the needs/preference of host-institution (such as independent administrative institution, university or graduate school), ICETT will invite a total of five (5) selected researchers to Japan for 240 days individually. Not only direct application but also recommendation someone for it is highly appreciated.

# 1. Name of the project

The project on Invitation to Japan for Environmental Research (PIER) 2011

# 2. Purpose of the invitation

The research fellows in developing countries will study the environmental technology development in Japan, with the support of host-institute, for a certain period.

The researcher will disclose the result through one's office in order to contribute to the environmental conservation in one's area/ country by both disclosure and technology transfer after returning.

#### 3. Areas of the environmental research

Should be chosen by the following four (4) areas:

- Air quality conservation issue,
- · Water quality conservation issue,
- · Waste treatment, recycling technology or creation of a recycling society issue, or
- · Prevention of global warming, energy issue

However, the research topic may not necessary to be "most advanced" type. Being low cost, easy-to-apply, and effective to environmental protection will also be acceptable. A new and unique idea of the applicants is encouraged.

# 4. Number of researchers to be invited

Five (5) persons in 2011.

#### 5. Period of invitation

240 days that includes both arrival and leaving days. (However, it may be shortened due to the applicant's proposal or condition of host-institute.)

Invitation should be one-time event. No one extend the period in the same or next year.

As a rough schedule, the start of actual research (in Japan) will be around June or July 2011.

#### 7. About the Host-institute

Certain research laboratories or units in academic institutions (such as independent administrative institution, university or graduate school) would be the host-institute. Based on the specified research topic and requests from both applicants (=overseas researchers) and the institutes in Japan, the Selection committee and ICETT will make the proper arrangement to adjust them.

After some coordination, then finally, ICETT will inform the result to the applicant whom to be the finally selected nominee.

# 8. Countries that can participate in this project

Developing countries listed in the DAC List\*3can apply to this project.

Especially for the countries and regional association/ commonwealth who had taken part in\*4 the 2005

World Exposition, Aichi, Japan, ICETT is willing to send information individually to their Embassy, Ministry of Environment, Ministry of Industry, Universities, etc. as much as possible in order to encourage their application. Means to provide the information are mainly by E-mail (and Fax).

# 9. Requirements for application

(\*4 see the end of this information.)

Applicants should:

- be environmental technical researchers in the office of governmental institutes, universities or graduate schools in the countries mentioned above;
   Even if falling under the right office category, researchers who are engaging in clerical or planning works cannot apply;
- be basically graduate of the graduate school (= should have taken at least the degree of Master);
- have more than five (5) years of practical working experience in the field of environmental research work, but not inclusive of internship period;
- be proficient in listening, speaking, writing and reading English for both living and the work.

  (In the all indicators, your answer should be ranked in the top 2 categories out of 4, by self-enumeration method. → See the "application form-A". If you have an official scores of English proficiency tests such as TOEFL or TOEIC, please attach the copy as much as possible); Note: If a researcher is found unable to achieve the research objectives due to language capability, he or she may be sent back to home country.)
- be basically under forty-five (45) years of age;
- be in good health, both physically and mentally, to undergo the activity.

- Note 1: For the smooth preparation of invitation arrangement, applicants should obtain one's boss's prior approval.
- Note 2: Applicants should submit (a) Application (Form A), (b) Abstract of current environmental research report (or Technical Paper), and (c) the institutional brochure.
  - The application form should be filled in English.
  - Form A: Consists of personal information, research experience information, motivation and expectation to the project participation, language skills and health information, and covenant clause. Please don't forget to fill/paste the signature in graphical mode.
  - Form B: The guideline of report structure and contents are shown in the end of the application form as Annex. Please check it.
  - Institutional brochure that tells the organization structure and related information.

All of these documents are used for the selection.

Note 3: Even though meeting all conditions, a person cannot apply if temporarily resides in Japan.

#### 10. Selection method

The Selection Committee composed of technical researchers and ICETT will screen and select the primary nominees in consideration for both the nominees and host-institutes so as to meet their requests/preferences.

If the application forms being not fully neither written nor fully submitted, it may bring disadvantages to the applicant but the selection committee doesn't inform.

# 11. Manner of giving notice

The result of nomination will be notified by ICETT through E-mail then postal mail as well. For the finally selected person, ICETT will send detailed information on staying in Japan and references for the research activity.

A complete dossier on invitation also is sent by registered express mail or courier service.

(The finally selected person is requested to send the agreement back to ICETT, as well as to start the preparation of passport and VISA application. This information will be provided respectively.)

# 12. Reference: Treatments on invitation

Air ticket: A round-trip air ticket in discount economy class between ICETT-designated international airport of the researcher's country and Japan, provided by ICETT;

Accommodation: An accommodation for single occupancy, located near from the research laboratory will be arranged and lent free by ICETT. Being attached bath, furniture, home appliances, cooking utensils, dinnerware, etc. are all equipped. Utilities cost such as water, lightning and heating expenses and Internet connection fee will also be covered by ICETT.

Some of additional commodities such as iron shall be lent by ICETT.

However, communication bill such as mobile phone should be paid from the researcher's own pocket;

Meal fee and daily allowance: Daily, 4,900 Japanese Yen will be paid based on the regulation of ICETT that includes the meal fee and basic allowance. However if the researcher comes from the country that doesn't conclude the Bilateral Tax Agreement with Japan or even does, if there contains special exemptions in the statement, the person should pay the given (=20) %age of the daily allowance to the Japanese Revenue Office.

Additional payment shall not be provided while the researcher goes for field trip.

On returning home, a small allowance for book shipping will also be prepared by ICETT.

Expense of Travel: Expense between the airport and accommodation, and official field trip will be covered by ICETT based on the regulation. A bicycle will be lent free individually for the daily purpose.

Medical & travel expenses: Covered by taking out insurance by ICETT. However, costs related to preexisting illness, pregnancy, or dental treatment are not included. This insurance is only effective from the day of arrival till the end of leaving Japan. Therefore, the overseas researcher must consider the insurance while on boarding international flight by oneself.

### 13. Other essential consideration

The applicant should agree that:

- the contents answered in the application form are true;
- to submit the 3 documents in a set: Form A, Form B and organization brochure;
- to understand that this project funds were donated from many people concerned to the 2005 World Exposition, Aichi, Japan .(http://www.expo2005.or.jp/);
- to complete the given periods for environmental research work and achieve success;
- Intellectual property right from the research achievement would be shared by the researcher and
  his/her host-institute. However, the two sides agree that ICETT may use only for the purpose of
  disseminate the project result for public relations activities, to the extent provided in individual
  agreement. In case, the two sides approve ICETT to disclose the information without charge;
- · while staying in Japan, to follow the rules of host-institute and terms and conditions of PIER;
- while staying in Japan, not to work nor receiving rewards due to visa regulations;
- in case of being from the country that does not conclude the Bilateral Tax Agreement with Japan, one is obliged to pay general income tax from the daily allowances provided by ICETT;
- overseas travel during the period of staying in Japan is not allowed;
- bringing one's any family member and/or living together is not allowed. Also, sharing the room with someone is prohibited, due to the rental agreement;
- after returning, one will disclose the research information for further technology dissemination/ transfer, and one will be willing to do concrete actions in tangible way such as advise younger researchers in the office belong or practical application of the technology;
- even after returning, one will be willing to keep in touch with one's host-institute and ICETT in order to strengthen information exchange.

#### 14. Before coming to Japan

Please study Japanese basic information and survival Japanese conversation by yourself, in order to survive life and enjoy the full period of staying independently.
