REMARKS BY THE VICE CHANCELLOR AT THE LAUNCH OF THE POSTGRADUATE DIPLOMA IN GENDER AND LOCAL ECONOMIC DEVELOPMENT & 7TH JARD, IMPERIAL ROYALE HOTEL, 13TH JANUARY 2011

Distinguished Officials of the JARD, Local Government Leaders, Development Partners Stakeholders in the Diploma Course on Gender and Local Economic Development, Distinguished Guests Ladies and Gentlemen

It gives me great pleasure to be a part of the launch of the Postgraduate Diploma in Gender and Local Economic Development. Local Economic Development is aimed at improving household incomes as a means of creating a stronger and taxable revenue and economic base. Therefore, launching this course during the course of the 7th Joint Annual Review on Decentralization (JARD) is indeed a great honour to Makerere University.

We are grateful to the Ministry of Gender, Labour and Social Development as well as Ministry of Local Government, for having selected Makerere University to plan and implement this course. We appreciate the financial support and advisory services on review of content for the Diploma, as provided by the United Nations Capital Development Fund (UNCDF), the UN Joint Programme on Gender and the International Labour Organization (ILO).

Makerere University as well as this forum of JARD, government and private sector, should look forward to effective impacts obtained from this course not only at national and district level but also in the international arena.

Makerere University identified gender mainstreaming as one of the issues of a crosscutting nature that impact directly on its activities. This course is therefore one of the true indicators of Makerere University's commitment to remain relevant to societal needs by strengthening skills and knowledge that enhances social inclusiveness, gender equality and empowerment of women.
