ABSTRACT

The study was carried out to establish the role human needs satisfaction can play in teachers' performance in secondary schools in Gasabo District. The objectives of the study were: to establish the relationship between physiological needs satisfaction and secondary school teachers' performance in Gasabo District; to find out the relationship between safety needs satisfaction and secondary school teachers' performance in Gasabo District; and to determine the relationship between social needs satisfaction and secondary school teachers' performance in Gasabo District. A non-experimental research design was employed for the study. This correlation study involved a total of 118 secondary school teachers from ten schools in Gasabo District. Data was analyzed using ANOVA, t-Test and Pearson's Linear Correlation Coefficiency (PLCC). The study findings revealed that whereas satisfaction of safety and social needs has significant positive relationship with secondary school teachers' performance in Gasabo District, satisfaction of physiological needs does not have significant positive relationship with teachers' performance.

The following conclusions were drawn from the study findings:

(i) Satisfaction of physiological needs does not have significant positive relationship with teachers' performance in secondary schools in Gasabo District; (ii) Satisfaction of safety needs has significant positive relationship with teachers' performance in secondary schools in Gasabo District; (iii) Satisfaction of social needs has significant positive relationship with teachers' performance in secondary schools in Gasabo District.

It was recommended that: (i) Even though satisfaction of physiological needs does not have significant positive relationship with teachers' performance in secondary schools in Gasabo District, they should be catered for since they are part and parcel of human needs. (ii) Safety needs should be consistently handled by responsible personnel since they have significant positive relationship with teachers' performance in secondary schools in Gasabo District. (iii) Social needs should be provided to make teachers more effective at work, since they have significant positive relationship with teachers' performance in secondary schools in Gasabo District.
