

**BID NOTICE UNDER OPEN DOMESTIC BIDDING****INVITATION TO BID FOR THE PROPOSED OVERHAUL OF TOILETS IN STUDENTS HALLS OF RESIDENCE, SELECTED ADMINISTRATIVE UNITS AND ACADEMIC BUILDINGS AND CONSTRUCTION OF NEW PUBLIC TOILETS****Procurement Reference number: MUK/WRKS/2011-2012/00710**

1. Makerere University has allocated funds to be used for the proposed overhaul of Toilet Facilities and Construction of new Public Toilets within the campus.
2. Makerere University invites sealed bids from eligible bidders for the procurements of the works on Toilets at main Campus according to the following lots;
Lot 1: Overhaul of Toilets in Students Halls of Residence
Lot 2: Overhaul of Toilets in selected Administrative and Academic Buildings
Lot 3: Construction of New Public Toilets.
3. Bidding will be conducted in accordance with the open domestic bidding procedures contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act, 2003, and are open to all bidders from eligible source countries.
4. Interested eligible bidders may obtain further information from Makerere University Procurement and Disposal Unit, Lincoln flats-A5 and inspect the bidding documents at the address given below at 9(a) from 8:00 am-5:00 pm.
5. A complete set of Bidding Documents in English may be purchased by interested bidders on the submission of a written application to the address below at 9(b) and upon payment of a non-refundable fee of Uganda shillings One hundred thousand (UGx 100,000).
6. The method of payment will be either a bank draft in the names of Makerere University Council or Cash payment at Stanbic Bank, Makerere University Branch A/C No. 0140018638901 and thereafter get a receipt from the University Revenue office in the Main Administration Building.
7. There will be a pre-bid meeting on Thursday 26th April 2012 at 10:00am in the Investment Board Room, Lincoln flats-C6 to allow bidders seek clarification on the solicitation document and also inspect the site of the proposed works.
8. Bids must be delivered to the address below at 9(c) at 10:00am on or before Friday 18th May 2012. All bids for Lot 1 must be accompanied by a bid security of ten million Uganda Shillings (Ushs. 10,000,000=) and All bids for Lot 2 & 3 must be accompanied by a bid security of five million Uganda Shillings (Ushs. 5,000,000=) each. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 9(d) on Friday 18th May 2012 at 10:15 am (local time).
