Master of Higher Education(MAHE)

Is offered by the East African School of Higher Education Studies and Development (EASHSED), College of Education and External Studies (CEES) main campus.

Target Group

MAHE targets current or prospective employees of higher education institutions or the higher education sub-sector such as research coordinators, quality assurance officers/directors, teachers/lecturers, leaders, managers, administrators, and researchers with scholarly interest in studies on higher education as a field.

Mode of Delivery

MAHE shall be delivered using a combination of approaches supported by self-study materials and activities.

These programmes are tenable at Makerere University Business School (MUBS), an affiliate to Makerere University.

Admission Requirements

General Makerere University Admission Requirements shall apply. In addition, eligible candidates must have the following qualifications:

A) Master of Higher Education

A good first degree or its equivalent in any academic discipline from a recognized and chartered university/institution. Candidates with a Pass Degree may be considered after demonstrating professional growth such as further qualifications or research and publications

B) Doctor of Philosophy in Energy Economics and Governance

Applicants should possess a Master's degree with Economics, Statistics, Mathematics, Quantitative Economics, Agricultural Economics, Engineering Physics, Commerce, Finance, Accounting, Business, Natural Resource, Geology and Mines from a recognized and chartered university/institution

C) Master of Energy Economics and Governance

Applicants should possess a first degree with a minimum of a Lower Second-class or its equivalent in the following disciplines; Natural Resources, Economics, Quantitative Economics, Agricultural Economics, Mathematics Statistics, Engineering, Geology and Mines, Law, Petroleum or mining engineering, Business and Management relate programmes from a recognized and chartered university/institution.

Application Procedure

1. Hard copies of application forms can be obtainable from the Directorate of Research and Graduate Training, 3rd Floor, Senate Building, Room 307 after payment of an application fee of Ug. Shs 50,000/= (Ugandan applicants) and Ug. Shs. 151,500/= (International Applicants) to any Stanbic Bank Branch, DFCU Bank, Centenary Bank or Post Bank using Makerere University paying-in-bank slips. International applicants can also pay by bank draft as cheques will not be honored.
