**RE: CALL FOR NOMINATIONS FOR THE POSTS OF GUILD PRESIDENT AND GUILD REPRESENTATIVE COUNCILLOR (GRC) 2020/2021.**

1. Pursuant to Guideline 1 of the Makerere University Guidelines for Conducting a Blend of Electronic and Physical Guild and Senior Common Room (SCR) Elections During the Period of the Covid-19 Pandemic (October 2021) and Article 73(3) of the Makerere University Students' Guild Constitution (as amended in February 2016), the Guild Electoral Commission hereby calls for nominations of Candidates for the positions of the Guild President and Guild Representative Councillor (GRC).
2. Nominations open with effect from today **Friday, 29<sup>th</sup> October, 2021** and shall close on **Tuesday, 2<sup>nd</sup> November, 2021** by 5:00pm.

4. Candidates for the post of Guild President and GRC are required to pay a **non-refundable** nomination fee of **UGX 200,000/=** and **UGX 80,000/=** respectively. Payment Reference Numbers (PRNs) should be obtained from the **Revenue Office at CTF 1, Level 4**.
5. Completed Nomination Forms, proof of payment of nomination fees, scanned testimonials, a coloured soft copy of the current passport photo and a coloured high resolution photo

which will appear on the ballot paper and the online voting system (saved as a pdf), should be sent to [87thec.mak@gmail.com](mailto:87thec.mak@gmail.com) by **Tuesday, 2<sup>nd</sup> November, 2021 by 5:00pm.**

6. All attachments to the email should be saved with the Candidate's full name as captured in the Makerere University database.
7. Candidates with disabilities **may** pick and return their nomination forms physically at the Guild Offices.
8. Only Candidates whose applications are received by the said deadline will be considered.
9. Candidates who satisfy the nomination requirements shall be issued with a Certificate of Eligibility to Contest by the Electoral Commission and declared as duly nominated for the respective position.
10. **All Candidates must acquaint** themselves with the provisions of the Makerere University Guidelines for Conducting a Blend of Electronic and Physical Guild and Senior Common Room (SCR) Elections During the Period of the COVID-19 Pandemic (October 2021), **particularly Guideline 7**, the Makerere University Students' Guild Constitution (Elections) Regulations No. 1 of 2018, **specifically Regulation 5**, and the Makerere University Students' Guild Constitution (as amended in February 2016), **particularly Article 72**.
